7. Has there been any sale of temple assets by any individual, which were provided on lease by the temple to anyone according to their lease policy?


To identify this it will be helpful if the temple assets holding in the year 1947, 1975, 1990 and 2011 can be made available separately.

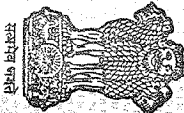
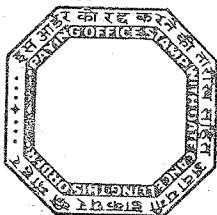
