- 1.2 Give copy of demand note issued for $\frac{3}{4}$ amounts & copy of chalan by which amount deposited for these plots.
- 1.3 If application for relaxation in date of payment was asked by owner of plots. If so give copy of that document & give me copy of decision of department regarding this application
- 1.4 Give me copy of document (notice, order, Demand notice & copy of chalan) by which remaining $\frac{3}{4}$ amount for plot which are mentioned in para 1.1, is deposited after expiry of deadline of first demand notice for $\frac{3}{4}$ amount.
