

COUNSELING FOR CAT-PG 2012

1 References:-

- (a) This Dte Gen letters of even dt 05 Sep 2011 and of even No dt 03 Nov 2011 asking for applications for CAT PG examination 2012.
- (b) This Dte Gen letter of even No dt 02 Feb 2012 declaring results.
- (c) TGC rules as amended.

2. On the basis of CAT-PG held on 15 Jan 2012 the officers listed at Appendix 'A' to this letter have been short listed for counseling for Advance Course (2012-2015) /PG course scheduled at AFMC Pune and other designated service training hospitals which will be held on 05 March 2012.

3. Available seats for Post Graduate seats based on teaching capacity and service requirement will be offered for allotment during the counseling exclusively on merit cum choice basis. PC officers with more than 10 years service and SSC officers in service bracket of 7-10 years will not be offered Advance Course / PG seats at AFMC Pune.

4. Officers listed in Appendix 'A' to this letter are required to report to this Dte Gen on 05 March 2012 with the certificates duly countersigned by their Commandant/COs as provided in Appx B (Part I and Part II). SSC officers should also be in possession of an affidavit on Non Judicial stamp paper of ₹ 50 as per Performa in Part III duly notarised.

5. The officers are required to report to the O/o DGAFMS/DG-1D at 0900 h for mandatory documentation process and checking of certificates and eligibility criteria. The counseling will be conducted by SGC on 05 Mar 2012 wef 1400h.

6. Officers should be in promotable medical category. Officers who are in Low Medical Category will only be permitted to proceed for PG course only on producing a certificate of being medically fit to pursue the PG course on the day of the counseling. The fitness certificate will be required to be signed by the Sr Adv of the specialty under whose purview the categorization of disease is applicable. Officers in Low Medical Category be detailed to report to nearest hospital having the requisite facilities for issue of the certificate by Sr Advisors concerned.

7. Merely being called for counseling does not guarantee detailment for Advance course/PG course. The eligibility for a particular course shall be determined at the time of counseling based on merit-cum-choice, service requirement, availability of vacancy, service, age, medical criteria, extant TGC rules and policies as issued by the Govt/MCI and affiliated university from time to time.


8. Administrative arrangements pertaining to accommodation, transport and so on may be made by the respective Med Dtes for the officers detailed for counseling.

9. It is noted that offrs often report late for counseling and unduly delay the proceedings. All offrs may thus be advised to report well in time for the counseling. Offrs who fail to report when called for counseling in their own turn, will not be considered subsequently under any circumstances.

10. It should be ensured by respective Med Dtes that offrs short listed for counseling are informed timely by faster means to enable them to attend the counseling as per schedule. The uniform for counseling is 'Summer dress with Peak-cap'.
