**Sub: Compliance Report in r/o implementation of directions issued by State Fee Regulatory Committee.**

Sir,

Several instances of over charging of fee other than as prescribed by the State Fee Regulatory Committee (for the year 2011-12) have been reported to Directorate of Higher Education by students of various self financing privately managed college under GGSIP University.

In this regard, it is reiterated that as per the Report of State Fee Regulatory Committee for the year 2011-2012, regulating the Fee Structure of Privately Managed Self Financed Institutions affiliated to Guru Gobind Singh Indraprastha University / Board of Technical Education, published in Part-IV of Delhi Gazette (Extraordinary) vide No. 276 dated 07/02/2012, and the direction issued by Joint Registrar (Academic) GGSIP vide letter dated 12.04.2012, it is clarified to all the Self Financed Privately Managed Institutions affiliated under GGSIPU that

" It was decided by the Committee that the tuition fee fixed by the State Fee Regulatory Committee is for the academic year 2011-2012 and no hike has been prescribed for students enrolled in the year 2010-11, so privately managed self financed institutions affiliated to GGSIPU cannot charge any extra fee from the students enrolled in 2010-11."

It was also decided that if any of the institution has charged any extra fee which is not prescribed by SFRC in its report for the year 2011-12, then such extra fee should be refunded to students, otherwise appropriate action will be taken against them as per Section 10(1), Section 17 and Section 18 of the "THE DELHI PROFESSIONAL COLLEGES OR INSTITUTIONS (PROHIBITION OF CAPITATION FEE REGULATION OF ADMISSION, FIXATION OF NON-EXPLOITATIVE FEE AND OTHER MEASURES TO ENSURE EQUITY AND EXCELLENCE) ACT, 2007."

Accordingly, all the self financing privately managed institutes affiliated under GGSIP University are required to charge fee only as per the directions given above and a Compliance Report to the effect that "Fee for academic year 2011-12 has been charged as per SFRC orders and any extra fees charged from students enrolled in 2010-11 batches have been refunded", be submitted to this Directorate latest by 04.09.2012.

This issue with the prior approval of the Competent Authority.
