- vii. MBA, MCA and PGDM with specializations,
- viii. M.Phil Programmes and
- Ex. Diploma and Certificates programmes using course materials of Director General of Employment and Training, Govt. of India.

The other B.Tech/B.E programmes being offered by St. Peter's University in conventional mode which are approved by AICTE may also be offered under distance education mode only after producing the required course materials.

The University is advised to develop the SLMs for all the programmes and provide extensive training to the faculty staff of ODL pedagogy & practices within 3 months from the date of issue of the letter for recognition and send a compliance report to the DEC.

The DEC does not allow franchising of study centers.

The territorial jurisdiction for offering programmes through the distance education mode would be as per the Acts and Statutes of your Institute, and as per guidelines of the DEC issued from time to time.
