

Point No. 7:- The reply furnished by the PIO is highly unsatisfactory. PIO should clearly mention whether the construction took place at I-135, Gali No. 10, Gharwali Mohalla, Lalita Park, Delhi-110092 is as per sanction plan or being done unauthorizedly. PIO should also mention whether the property in question has been booked or not.

Accordingly, Appeal is disposed off.

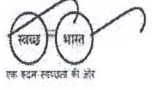


